The aim of this programme is to educate people of the risks that the online world can have on everyday life by improving online awareness in schools and to parents and guardians. ## A view to what each lesson covers

#### **Online Safety Year 3**

In this lesson the children will go through what personal information is and is it appropriate to be placing online. We will be looking at what makes a good password and why it is important to keep passwords safe. At the end of the presentation we will be giving some top tips to remain safe while using the internet. In the lesson the children are asked to carry out activities to make them think about the virtual world through working as a group and discussing certain topics found within the PowerPoint presentation.

#### **Online Safety Year 4**

In this lesson the children will go through the law linked to the online world, looking at what may constitute an offence and the penalties each offence could carry. We look at what Wi-Fi is and how to remain safe while using it. We will also go through "do they know who they are talking to online" making sure that they understands the importance of knowing who they are before divulging any information about their personal lives. At the end of the lesson we will go through some top tips to children make the right choice while online. The children will be in groups and will be competing in a quiz throughout the PowerPoint presentation with the aim for the children to be online safe, online aware and online smart.

#### Online Safety Year 5

In this lesson the children will go through what the technology was back in the 90s in comparison to today. We will take a look into the virtual world with an overview in to social media. We will cover copyright laws outlining the rules of piracy and plagiarism. In this presentation there is an element of group work looking at what pictures are suitable to be places on the internet. We will cover aspects on online garning and what to do if something is inappropriate while playing games online. We will discuss child exploitation and online protection giving some top tips to help children make the right choice when online.

### Online Safety Year 6

In this lesson the children will go through what is the virtual world and looking at the laws around social media. We will explain that by one person posting something on social media it may also affect others (the ripple effect). We will inform the children of the laws around indecent images in a section about Selfies and webcams, also looking at what is age appropriate material such as games and websites. At the end of the presentation we will offer some top tips that will help children make the right choice when online. The children will be asked to work in groups to write down what they think the virtual world is and what methods can be used in the virtual world. We will go through a few laws that can be broken from sending malicious messages.

#### **Online Bullving Year 5**

In this lesson the children will go through what online bullying is and who can be the victims of it. We will go through what laws can be broken and the punishments for online bullying. We will be talking about the signs people portray when they are a victim of online bullying and who can help to prevent it from happening. We will explain what trolling is letting them know it is someone who sows discord on the internet by starting arguments or upsetting people. We will look at who are the main perpetrators and who are the main victims of online bullying. We will finish of the presentation by giving some tips on how to help children make the right choice when online. The children will be participating in questions around online bulling and asking for the children's views on online bullying.

#### **Online Bullying Year 6**

In this lesson the children will participate in a group discussion on what they know and understand about online bullying. We will then explain what constitutes online bullying going through the laws and punishments for any laws that may be broken. We will go through some statistics around social media looking at how much information is publicised online every minute of every day. At the end of the presentation we will offer some tips to help children make the right choice when online.

# Parent/guardian PowerPoint presentations

For parents/guardians we have 5 separate presentation as listed below. We also offer an all in one presentation that lasts approximately 2 hours combining all five of the presentation. The aim of these presentations is to aid in educating the parent/guardians in the virtual world so that they can have the relevant information to help keep their children safe in the future while they are online.

## A view of what each lesson covers

We will go through the basic aspects that creates the virtual world. We will inform them about online gaming and how their children can be targeted through playing games online. We will explain that what we know about the internet is only the tip of the iceberg telling them that there is a dark side to the internet where crimes can take place. We will talk about the laws and punishments around the online world and social media like fraud. At the end of the sessions we will give some tips about how they can help keep their children safe while online. Within the lessons the parents/guardians will be asked to answer questions about their knowledge of the virtual world. We will be looking at what online applications the children are using the most with notes on what each application is used for and how it can be used. In the presentations there are short educational video clips explaining the different elements that children use and looking at what sexting is and what constitutes as online bullying and the social risks behind them all.

### **Staff Training**

In this training package we cover the apps that children are using, why it's important for schools to understand online safety, and how staff internally can be effected by social media.
